1.INTRODUCTION

Maharashtra State Khadi & Village Industries Board (MSKVIB, was established in १९६१. Located at १९/२१.Manohardas Street, Fort, Mumbai ४००००१ its objective is to promote khadi and village industries in the State of Maharashtra. MSKVIB invites proposals from manufactures/authorized suppliers for supply of beekeeping equipment's, Apis Mellifera bee boxes with bee colonies and other equipment's required for distribution to the beneficiaries under the scheme Honey Centre.

२.DEFINITIONS

“Applicable Law” means all relevant laws in force and effect as of the date hereof and which may be promulgated or brought into force and effect here in after in India, Including judgment, decrees, injunction, Writs or orders of court, as may be in force and effect during the subsistence of this Tender Document. **“Bid Document”** shall mean the document submitted by the Bidder, pursuant to understanding and agreeing with the terms and conditions set out in this Tender Document.

“Contract” shall mean the sale agreement to be entered in between MSKVIB and the successful Bidder.

“MSKVIB” shall mean Maharashtra State khadi & Village Industries Board constituted under the provision of Bombay Khadi and Village Industries Act, १९६०. **“CEO MSKVIB”** shall mean. to natural persons, partnership firms, companies, bodies corporate and associations, whether incorporated or not or any other organization or entity including any government or political subdivision, ministry, department or agency thereof;

(c)References to clauses, recitals or schedules are references to clauses and recitals of and schedules to the contract and the Tender Document. The Schedules, annexure and addendums shall form an integral part of this contract.

5. DUE DILIGENCE

The Bidder is expected to and shall be deemed to have examined all instructions, forms, terms and specifications in this tender document. The Bid should be precise, complete and in the prescribed format as per the requirement of the tender Document. Failure to furnish all information required by the tender Document or submission of a bid not responsive to the tender Document in every respect will be at the Bidder's risk and may result in rejection of the bid. CEO MSKVIB shall at its sole discretion be entitled to determine the adequacy/sufficiency of the information provided by the Bidder.

7. COST OF BIDDING

The Bidder shall bear all costs associated with the preparation and submission of its bid and CEO, MSKVIB shall in no event or circumstance be held responsible or liable for these costs, regardless of the conduct or outcome of the bidding process.

8.CLARIFICATION OF BIDDING DOCUMENTS

CEO, MSKVIB shall make best efforts to respond to written request by the prospective bidder for clarification, if any, on the tender document.

9.AMENDMENT OF TENDER DOCUMENT

At any time before the deadline for submission of bids, CEO, MSKVIB may, for any reason whether at its own initiative or in response to a clarification requested by a prospective Bidder, modify the Tender Document by amending modifying its terms and conditions and/or supplementing the same.

All changes shall be posted on website of <https://mahatenders.gov.in> and prospective Bidders are required to go through the same before submission of bid. All such amendments shall be binding them without any further act or deed on CEO, MSKVIB's part. In the event of any amendment, CEO, MSKVIB reserves the right to extend the deadline for the submission of the bids, in order to allow prospective bidders reasonable time in which to take the amendment into account while preparing their bids.

११.GENERAL INSTRUCTIONS

The Bidders are requested to read the tender document thoroughly.

११.१ Bidder is one who has responded to the bid for supply of beekeeping equipment's, Apismellifera bee boxes with bee colonies and other equipment's required for distribution to the Beneficiaries under the scheme Honey Centre and other Govt. Schemes.

११.२ In the event of any additional information required by the CEO, MSKVIB other than that specified in the per-Qualification criteria, the Bidder to the CEO, MSKVIB shall duly

submit such information in the prescribed time. The Bidder shall submit the tender document duly signed on each page as a part of the bid. It shall be Expressly agreed herein by the bidder that he has read and understood the complete tender Document and other documents/ requirements and shall comply with the same expect what is stated in specified Deviation/ Non-Compliance statement format.

99.3 Bids received with incomplete information/document shall be rejected. Bids not adhering to terms, Conditions, Specification and other details as given in this document may be summarily rejected

99.8 This tender document is not transferable.

99.4 Modification or withdrawal of Offers is not permissible after its submission. If the offer is withdrawn before the Validity period indicated in Para 99 the EMD will Stand forfeited. To assist in the scrutiny, evaluation and Comparison of offers, CEO, MSKVIB may ask some or all Bidders for clarification on some of the points of their offer. The bidder shall provide the necessary clarification within the stipulated time schedule.

99.6 Preliminary scrutiny: CEO, MSKVIB will scrutinize the offers to determine whether they are complete, whether any errors have been made in the offer, whether required technical documentation has been Furnished, whether the documents have been properly signed and whether items are quoted as per the Schedule CEO,MSKVIB may, at its discretion, waive any minor non-conformity or any minor irregularity in an offer. This shall be binding on all Bidders and CEO, MSKVIB Reserves the right for such waivers.

99.9 Bidders should not have been barred and violated any terms and conditions including supply of material within stipulated period of the tender, which have been awarded in the past by any of the Government Undertaking/Department.

99.2 Award Criteria: Technical Offers in will be evaluated first to check whether all required Information and document as specified In the Tender Document are submitted and to ascertain whether the Bidder meets all Qualifying Criteria. The Bidders who's Technical Office are found to be in accordance with the specifications mentioned in the tender document would be short-listed and only their Commercial Bids will be opened.

११.१ The Bidder should abide by the terms and conditions specified in the tender document. If Bidders submit conditional offers, they shall be liable for outright rejection. The CEO MSKVIB shall be under no obligation to accept the lowest or any other offer received in response to this tender notice and shall be entitled to reject any or all offers including those received late or incomplete offers without assigning any reason whatsoever. The C.E.O., MSKVIB reserves the right to make any changes in the terms and Conditions of the tender prior to the last date of submission by publishing the changes on the site of <https://mahatenders.gov.in>. The offers containing erasures or alterations will not be considered. Technical details must be completely filled in. Correct technical information of the service being offered must be filled in. Filling up of the information using terms such as “ok” “accepted”, “Noted”, “as given in brochure manual” is not acceptable. CEO, MSKVIB may treat offers not adhering to these guidelines as unacceptable. Bidders are not allowed to subcontract in any manner without written approval from CEO, MSKVIB.

१२. QUALIFICATION CRITERIA OF THE BIDDER

12.1 Bidder should have own beehive manufacturing unit with advance scientific techniques.

१२.२ Bidder can be a proprietary or Partnership Firm or LLP or Pvt. Ltd. or Limited Company or Registered Society or Social Charity Trust or MSKVIB/KVIC registered unit.

१२.३ Bidder should be a bee breeder & have **Minimum १० years° Experience** in Beekeeping

१२.४ Bidder may be the member of NBB (National Bee Board) for a minimum of last ५ years & should have Minimum १००० Bee hives of the bee breeds in apiary as per NBB. Attach certificate.

१२.५. Minimum sale of Beehives bee colonies & Beekeeping Equipment°s minimum **Rs. २५ lacs/year**

१२.६. Minimum १००० Bee colony of Apismellifera stock of last year as per stock statement & Balance sheet of last year.

१२.७ The Bidder should have capacity to supply the material at their own cost.

१२.८ The bidder should have technical personnel for installation and supply of beekeeping equipment°s, Appis Mellifera bee boxes with bee colonies .

१२.९ They should have GST, TAN, and PAN.

13. EARNEST MONEY DEPOSIT (EMD)

93.9 Bidders are required to pay **Rs.3,000/- (Rs.Three Thousand only)** towards processing fee in the form of DD of Nationalized bank/Bank order drawn in favors of “**Maharashtra State Khadi & Village Industries Board.**” Payable at Mumbai. The processing fee is non-refundable.

93.2 The bidder should also pay Rs.20,000/- (Rs. Twenty Thousand only) as earnest money deposit (EMD) for the bids in form of Demand Draft/pay order of Nationalized bank drawn in favor of -Maharashtra State Khadi& Village Industries Board° payable at Mumbai.”

93.3 Processing fee & EMD Demand Drafts/pay orders receipt of payment of processing fee should be part of technical bid.

93.8 The EMD is non-interest bearing and is refundable to unsuccessful bidders after one month of signing of the contract by the successful bidder.

93.4 The EMD of successful bidders will be released upon expiry of “offer Validity Period” as mentioned in instruction to Bidder.

93.6 The EMD will be forfeited if a bidder withdraws his bid during the period of validity Or in case of a successful bidder, If the Bidder fails.

- a) To sign the contract in accordance with terms and conditions.
- b) To furnish Bid security as specified in terms and conditions.

98. OVERALL EVALUATION METHODOLOGY

98.9 CEO, MSKVIB shall evaluate and compare the bids determined to be Substantially Responsive. Any effort made by the Bidder to influence officials of CEO, MSKVIB in the evaluation/contract award decision, may result in the rejection of the Bidder's bid. It is CEO, MSKVIB's intent to select the bid that is most advantageous to CEO, MSKVIB and each Bid will be evaluated using the criteria and process outlined below. The CEO, MSKVIB reserves right to reject any or all bids without assigning any reasons.

98.2 Bidder should bring the catalogue and diagrams and samples of the supply of beekeeping equipment's, Apis Mellifera bee boxes with bee colonies and other

equipment's required for distribution to the beneficiaries under the scheme Honey Centre and other Govt. Schemes and submit before Committee for inspection at the time of technical bid opening. The Technical and Commercial evaluation of Bids shall be carried out by the C.E.O., MSKVIB. Only those commercial Bids who qualify in the technical evaluation shall be considered.

98.3 The Commercial Bid (which is technically qualified) with the lowest offer will be eligible for further negotiations with CEO, MSKVIB.

99. EVALUATION OF BIDS

99.1 The Bidding process shall be a two-stage process. Prior to the detailed evaluation of the Technical Bids, CEO, MSKVIB shall determine whether each bid is (a) complete (b) is accompanied by the required information and document and (c) is substantially responsive to the requirements set forth in the tender document. A substantially responsive Bid is one, which conforms to the requirements, terms, conditions and specifications of the Tender without any deviation. C.E.O., MSKVIB, evaluation in this regard shall be final and binding on all Bidders.

99.2 Based on the results of the Technical evaluation, C.E.O., MSKVIB shall then proceed to open and evaluate the Commercial Bid of those Bidders who qualify in the Technical evaluation. The Commercial evaluation will take into account the information supplied by the Bidders in the Commercial Bid, and the same shall be evaluated in accordance with the evaluation criteria specified in the tender document.

99.3 C.E.O., MSKVIB may at its sole discretion, waive any minor infirmity or non-conformity of irregularity in a Bid Document, which does not constitute a material deviation, provided such a waiver does not prejudice or affect the relative ranking of any Bidder.

99. Tender Evaluation Committee

The C.E.O., MSKVIB will constitute the Tender Evaluation Committee. This committee will evaluate the Bid Document submitted by the Bidders. The Tender Evaluation Committee may choose to conduct technical negotiation or discussion with any or all the Bidders. The decision of the Evaluation committee in the evaluation of the Technical and commercial bids

shall be final and binding on all the parties. Any effort by a Bidder to influence the member of Tender Evaluation Committee during processing of Bids, may result in the rejection of Bid.

90. UNDERTAKING

An undertaking from the Bidder stating the compliance with all the condition of the contract and Technical Specification of the Bidding Document will be required since no deviation will be acceptable to C.E.O., MSKVIB.

१८.BID PRICE

- १८.१** The commercial offer must be made by the intending bidder converging all important points mentioned in the bid format enclosed in this bid document. The commercial offer may be submitted keeping in view the terms and condition of this bid document and site conditions.
- १८.२** The bidder shall include payment of all dues such as excise, taxes, packing forwarding charges, freight charges, insurance charges, installations/trial and commissioning, demonstration etc., not specifically mentioned in the specification but essential for supply of beekeeping equipment's, bee boxes Apis Mellifera bee boxes with bee colonies and other equipment's required for distribution to the beneficiaries under the scheme Honey Centre and other Govt Schemes.
- १८.३** The bidder shall not be eligible for any extra charges in respect of such payment. Though not mentioned in the bid document, any other applicable taxes/duties shall be paid by the bidder only.
- १८.४** All liabilities, whatsoever, on account of variations in Govt. Policy or any other reason, if any shall be borne by the bidder, during the tenure of the contract.
- १८.५** Any royalties or patents or the charges for the use of infringement thereof might involve in the contract shall not be paid by C.E.O., MSKVIB. The bidder only shall pay for such claims without putting any financial burden on MSKVIB.

१९.PERIOD OF VALIDITY OF BIDS

१९.१ VALIDITY PERIOD

Bids shall remain valid for ३ years (Three years) after the date of bid opening prescribed by C.E.O., MSKVIB.

१९.२ Extension of period of Validity

In Exceptional circumstances, CEO, MSKVIB may solicit the Bidder's consent to an extension of the period of validity shall be unconditional. The EMD validity provided shall also be suitably extended.

SECTION- 2
TENDER CONDITIONS AND SCOPE OF WORK

2.1 SUPPLY TERMS

- a) Material for supply of beekeeping equipment's, and Apis Mellifera with bee colonies and other equipment's required for distribution to the beneficiaries under the scheme Honey Centre and other Govt. Schemes should be as per specifications and drawings given as per ISI standards.
- b) Successful bidder need to submit certificate/authenticity report of supply of material from competent authority acceptable To C.E.O., MSKVIB at the time of supply. Whenever applicable
- c) Successful bidder should give delivery of all equipment's material at the locations identified by the MSKVIB.
- d) No additional charges will be paid for packing forwarding, freight, Insurance, installation/trial commissioning/demonstration and for visit of officials.
- e) Any damage caused to equipment / material during transportation shall be the sole responsibility of bidder. CEO, MSKVIB will not be responsible for such damages.
- f) No advance will be paid against the issuance of order.
- g) Delivery beyond the stipulated period of delivery schedule will attract suitable penalty decided by the MSKVIB Authority.
- h) The C.E.O. MSKVIB will send the letter of award to the successful bidder online and by post. The successful bidder should also acknowledge the receipt of the order online to the CEO, MSKVIB by letter sent by Register post.

2.2 PAYMENT TERMS:

- a) Supplied Bee boxes, colonies & equipment's will be inspected by the respective team of MSKVIB within 9 days from delivery of materials & reports must be submitted within additional 3 days.
- b) Payment shall be transferred through RTGS after satisfactory report from the authorized inspection team of MSKVIB.
- c) **Delivery period:** – The delivery of equipment's and material will have to be made to the destinations as mention on purchase order. However, the entire consignment should be executed within stipulated time given from the date of issue of supply order.

2.3 SECURITY DEPOSIT

a) The successful bidder shall have to deposit security Rs 90,00,000 by way of bank guarantee in the name of “**Maharashtra State Khadi & Village Industries Board**” payable at Mumbai within 90 days from the issue of letter of acceptance.

b) Failure to comply with the terms regarding Security Deposit shall entitle C.E.O., MSKVIB for cancellation of the supply order without any further reference to the Bidder and the EMD shall be forfeited.

c) The security deposit will be refunded after the satisfactory completion of obligations by the Successful bidder as per the terms of contract/bid document. Any violation of terms of agreement will lead to termination of the agreement and will result into forfeiture of security deposit.

2.4. INSURANCE

The successful bidder will have to make necessary arrangement to deliver the Bee boxes with colonies & Equipment's at the destinations all over Maharashtra with cover of all related risks such as transit, theft, fire, riots, earthquake, flood other natural calamities etc. at his cost.

2.5 OTHER TERMS:

a) The agreement with the successful bidder for supply of beekeeping equipment's, Apis Mellifera bee boxes with bee colonies and other equipment's required for distribution to the beneficiaries under the scheme Honey Centre and other Govt. Schemes as per purchase order placed time to time. Will remain enforce for a period of 36 months from the date of its execution with an option with the CEO, MSKVIB to enhance the same for further period on mutually understanding.

b) Termination of contract by successful bidder before completion of contract 36 months will result into forfeiture of entire security deposit.

c) Catalogues/brochures should be enclosed given technical details of the offered material in original. All specifications should be substantiated by separate sheets in original.

- d) Rate should be quoted both in figures and words. Rate should be Quoted per item/per piece/per number.
- e) No assistance in obtaining import license or any license/permit etc. in aspect of raw material or finished good of accepted items will be provided by C.E.O., MSKVIB
- f) Bidder must distinctly understand that they will not be allowed any increase over the rates quoted by then during the contract period.
- g) Manufactures/authorized suppliers/Contractors should satisfy themselves that the stores are in accordance with the terms of the contract and fully confirm to the required specifications. 
